Funding may be used for a variety of improvements to your home including windows, roofing, electric, plumbing, heating and obvious structural defects. Program guidelines require manufactured housing to have a permanent foundation.

Funding is limited, and not all eligible residents are guaranteed assistance.

## **Income Guidelines**

Eligibility for the Owner Occupied Residential Rehabilitation Program is based upon total household income.

Total household income will include, but is not limited to:

- Wages of all family members
- Social Security
- Disability
- Unemployment
- SSI
- Interest Income
- Pension
- Public Assistance
- Alimony
- Child Support

## How Do I Get Started?

- •Fill out the attached information card and mail it back to us or drop it off at our office.
- •Once we receive your information, you will either be placed on a waiting list or we will mail you an application package. If you have any questions on completing the application, please contact our office.
- •Eligibility requirements include:
  - ⇒ Total household income
  - ⇒ Proof of Ownership
  - ⇒ Paid Property Tax Card
  - ⇒ Federal Income Tax Return
- •A home inspection and a work specification along with a cost estimate will be completed to assist contractors in their bids.
- •Bids will be selected from approved, licensed, and insured contractors.
- •Should the cost of the improvements exceed the grant amount of \$12,000, you may be responsible for the excess.
- •Grant awards are up to \$12,000 on a first come, first serve basis for eligible homeowners. A 5 year lien is placed on each eligible property and is decreased at 20% per year. Once the lien is satisfied, it will be removed.

An additional grant of up to \$2,500 is available to assist persons with disabilities for modifications necessary for accessibility.
